

**RESOLUTION OF THE BOARD OF DIRECTORS
OF CAMINO BANDERA HOMEOWNERS ASSOCIATION, INC.
FOR GARBAGE CONTAINER GUIDELINES**

COUNTY OF BEXAR } **KNOW ALL MEN BY THESE PRESENTS:**

Pursuant to Sections 201.010 and 202.011, Texas Property Code, Camino Bandera Homeowners Association, Inc., acting through its Board of Directors, has adopted the following reasonable guidelines for storage and placement of "garbage containers", to-wit:

1. Receptacles for garbage, recyclables, and refuse will be considered in violation of Article XV of the Covenants if they are placed on the street for pickup or moved and stored out of sight after pickup no earlier than the day before and no later than the day after the designated pickup dates.

Currently, the "brown" garbage receptacles have a Friday pickup date and the homeowner would be in violation of Article XV if the receptacle is not stored out of sight between Sunday after the schedule pickup and Wednesday prior to the scheduled pickup.

The "blue" recyclable and "green" refuse/compost receptacles have a Tuesday pickup date. The homeowner would be in violation of Article XV if the receptacle is not stored out of sight between Thursday after the scheduled pickup and Sunday prior to the scheduled pickup.

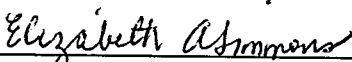
2. The designated pickup dates for garbage containers are set by the City of San Antonio Waste Management and these dates may be changed by the City accordingly.
3. The Board of Directors will reserve the right to change this Association Guideline as needed by the Association.

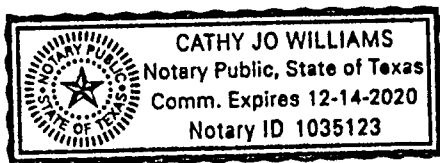

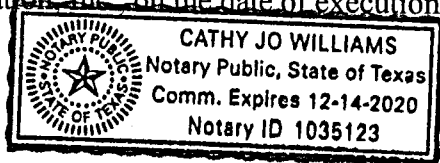
